### Prysmian Group Signs Contract for Land Purchase for New Submarine Power Cable Plant in USA

**Prysmian Group** is moving ahead with its project for a new submarine power cable plant in the USA. Prysmian Group and **CDC Commercial Development Company** have signed a contract for the purchase by Prysmian of the site identified in Brayton Point, MA, USA. The final acquisition of the site is subject to securing state permits for construction of the new plant. Prysmian’s investment to build the new plant will total around US\$200 million.



Finalization of the plans for the USA localization of the submarine cables plant footprint also entails confirmation of the award of the projects for cabling the Commonwealth Wind and Park Wind City offshore wind projects, for a total of some US\$900 million, by **Avangrid Renewables**, a subsidiary of **AVANGRID**. The notice to proceed is yet to be issued.

“We are very pleased with the agreement reached with CDC and the progress of our project to build a new plant in Brayton Point,” said **Hakan Ozmen**, EVP Projects Business at Prysmian Group. “The new plant will allow us to provide even closer support to our customers and gain a strong competitive advantage in a market expected to undergo sharp growth, with the goal of 30 GW of new capacity to be installed by 2030.”

“For the past four years, **Brayton Point LLC** has worked to reposition and prepare Brayton Point Commerce Center for offshore wind and other port-related activities. We are pleased Prysmian Group will bring excellent jobs and investment to Somerset by building a high-tech cable factory,” said CDC EVP **Stephen R. Collins**. ### Aurubis to Build Nickel & Copper Recycling Facility in Belgium

**Aurubis** will invest some €70 million in the construction of a state-of-the-art and energy-efficient bleed treatment facility at its Olen, Belgium site. In a hydrometallurgical process, the BOB (Bleed treatment Olen Beerse) will recover valuable metals such as nickel and copper contained in electrolyte streams that are generated in the tank houses of the metal production at the Aurubis sites in Beerse and Olen in Belgium. The installation comprises a complete tank house purification system that

### Prysmian: Record €4.8 billion project orders secured in 2021

The Board of Directors of **Prysmian Group** has approved the Group's consolidated results for 2021

"The recovery trend gained pace at the end of the year, allowing the Group to close 2021 with sharp growth in revenue and exceed the guidance previously announced to the market," said CEO Valerio Battista. For the first time, sales exceeded €12 billion, a record milestone, and Adjusted EBITDA grew sharply, with stable margins despite significant rises in commodity prices. In particular, the results were driven by the resilience of the energy business segment and the recovery in telecom. Flawless execution of submarine cable projects in progress, also led to a recovery in the Projects segment, a business positively exposed to the energy transition, where the Group has reaffirmed its technological and market leadership, acquiring record

orders worth €4.8 billion in the year. "We started 2022 with the same conviction and determination, which includes setting ambitious new targets for the year, with an expected adjusted EBITDA from €1010 million to €1080 million and a free cash flow target of €400 million, ±15%," concluded Battista.

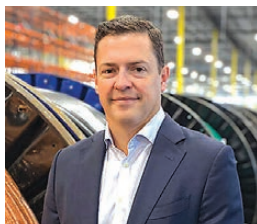

### Elcowire completes acquisition of KME rod & wire business

Elcowire Group, Helsingborg, Sweden, has now completed the acquisition of KME's **-elcowire** copper wire rod, wire and strands business in Hettstedt, Germany, doubling Elcowire's production capacity to 300,000 tons per year.

The acquisition provides Elcowire with access to greater capacity, a broader product portfolio and a greater market coverage.

The Elcowire Group, has streamlined its operations during the time of the COVID pandemic, divesting its China operations and relocating and closing its Mannheim production, taking a major step to becoming a significant supplier of copper wire rod in Europe.

A part of the new business and operation will be formed into the Wire & Strands unit, joining the existing Rod, Rail, High Voltage and Specials units.
